Eligibility

This is an open competition for all artists 18 and over working in two-dimensional, representational fine art. All 2D mediums photography and computer except generated artwork of any kind. Hand pulled prints in numbered editions are permitted. The mission of the Atlanta Fine Arts League, Inc. is to advance and promote the fine art of representational realism. NO class work, supervised work, abstracts, copies, giclees or computer generated art are eligible and will not be accepted. Works previously exhibited in an AFAL National Exhibition are not eligible.

Jury Process

Jury by digital file submission only. Entrants may submit up to three images for consideration. Please do not submit images of any work that is not available for display. If you are accepted and withdraw your piece, you will not be able to exhibit in an AFAL exhibition for two years. No

substitutions will be accepted. Size requirements are NO LARGER than 40x40 <u>FRAMED</u> with the width (top & bottom) being NO LARGER than 40 inches. This means the outer measurements of your frame.

PLEASE NOTE:

ALL DIGITAL IMAGES WILL BE PRINTED FOR COMPARISON TO EACH PAINTING FOR ACCURACY. IF THEY DO NOT MATCH THEY COULD BE REJECTED.

Image Requirements

Please use a non-smearing pen when labeling CD. When emailing or mailing a digital file make sure the image is right side up. Please make all digital entries RGB/.jpg format, 300 dpi resolution and 900 pixels the longest dimension. In the body of the email or on the CD indicate the title, medium and size of the artwork as well as the dimensions of the outer portion of your FRAME. Only the canvas image should be seen in the image. When saving your image make sure it is labeled as

YourLastName.Title.jpg.

EXAMPLE: Smith.AppleswithKettle.jpg

Framing Requirements

All accepted work must be properly framed, wired and labeled and have a suitable backing-paper, cardboard, foam board, etc. No clip frames will be accepted. Juried work will not be hung if it does not meet these guidelines. On the back of each painting, attach a 3x5 card to the top right hand corner with your name, title, medium, price and phone number.

Delivery and Hanging

Accepted work must be delivered between 10 AM and 4 PM on Monday, August 30 and Tuesday, August 31, 2010.

Shipped Artworks

Out of town entries that are accepted will receive detailed information regarding shipping.

- A fee of \$45 for one painting in one box or \$50 for two paintings in one box will be required for all shipped entries to cover unpacking, delivery, pickup and repacking of artwork only. Return shipping instructions will be included in the detailed information if you are accepted.
- No glass will be accepted for shipped work. Plexi-glass only.
- Artist is responsible for insurance.
- Shipping Agent will accept and return boxes from ANY shipper (UPS, FEDEX or USPS)
- Shipped works must be received by the agent between August 23rd & 27th. Accepted artists will receive shipping instructions along with their acceptance form.

Removal of Work

Work is to be removed between Monday, September 27 and Wednesday, September 29 between 10AM & 4PM. No paintings or sculptures may be removed prior to that time. Please inform your client or gallery of the time frame in which the painting will be on view. AFAL and the gallery are not responsible for any works left after the pick up dates.

Insurance

The Abernathy Arts Center nor does the AFAL, Inc. carries no liability insurance and assumes no responsibility for the safekeeping of the artwork. The Artist agrees to release the Abernathy Arts Center & the Atlanta Fine Arts League, Inc. from all liability including, but not limited to, liability for personal injury, theft of/or damage to the artwork, or the theft of/or damage to the collection or the proceeds from its sale.

<u>Sales</u>

The Atlanta Fine Arts League will retain a commission of 20% for any sales during the show or that result from the show.
